CHARGE ACCOUNT TERMS AND CONDITIONS

Buyer _____ agrees with seller, **Ayer Oil Co., Inc.** to pay for all purchases upon receipt of monthly statement. Charges billed, but not paid by the 15th of the month following purchase will be considered delinquent and subject to **finance** charges.

The FINANCE CHARGE for individuals is computed by a periodic rate of 1.5% per month with an **ANNUAL PERCENTAGE RATE OF 18%** applied to the "Previous Unpaid Balance Less Current Credits." Current credits are payments or credits received by 8:00 A.M. on the 15th day of the following month. The minimum payment due will be payment of the Buyers indebtedness in full. If not paid, **Ayer Oil Co., Inc.** may declare the unpaid balance due and payable immediately. Buyer agrees to pay collection expenses, including reasonable attorney's fees and court costs, if it is necessary to collect through legal action.

Buyer assumes full responsibility for all materials purchased from **Ayer Oil Co., Inc.** Buyer agrees to be personally liable for all charges and individually guarantees payment of all charges promptly. Buyer agrees to notify **Ayer Oil, Co, Inc.**, within 10 days in writing of receipt of monthly statement of any discrepancies in billing. Failure to notify **Ayer Oil Co., Inc.** signifies total acceptance and responsibility for prompt payment in full of account.

Buyer agrees not to exceed their predetermined credit limit.

If the Buyer fails to abide by the terms of this agreement, **Ayer, Oil. Co., Inc.** reserves the right to terminate fuel deliveries or service without notice. Damage, because of termination, property or otherwise, will be the responsibility of the Buyer.

Ayer Oil Co., Inc. reserves the right to send out "Notice to Owners" and file for Liens on past due accounts and use any legal means available to force collection if necessary.
